**RESOLUTION OF THE BOARD OF DIRECTORS
OF THE
GREEN GABLES METROPOLITAN DISTRICT NO. 1**

A RESOLUTION CALLING AN ELECTION FOR DIRECTOR POSITIONS

WHEREAS, two directors must be elected to a three-year term; and

WHEREAS, successors to these director seats are to be voted upon at the regular District election scheduled for May 3, 2022 (“**Election**”) as required by the Special District Act, Title 32, C.R.S. (“**Act**”); the Uniform Election Code of 1992 and the Colorado Local Government Election Code, Title 1, Article 13.5, C.R.S. (the “**Code**”); and

NOW THEREFORE, be it resolved by the Board of Directors of the Green Gables Metropolitan District No. 1 as follows:

1. Date and Time of Election. The regular election shall be held on May 3, 2022, between the hours of 7:00 A.M. and 7:00 P.M. pursuant to and in accordance with the Act, the Code and other legal requirements. At that time, two directors shall be elected to three-year terms.
2. Conduct of Election. The Election shall be conducted as an independent mail-ballot election pursuant to Article 13.5 of Title 1.
3. Designated Election Official. Natalie Fleming shall be the Designated Election Official (“**DEO**”). She is authorized and directed to proceed with any action necessary or appropriate to effectuate the provisions of this Resolution and of the Act, Code, or other laws.
4. Self-Nomination and Acceptance Forms. Self-nomination and acceptance forms for the director positions are available at the DEO’s office: 7400 E. Orchard Road, Suite 3300, Greenwood Village, Colorado 80111, or by requesting a form via telephone or e-mail: (303) 770-2700 or nfleming@svwpc.com. All candidates must file self-nomination and acceptance forms with the DEO no later than 5:00 P.M. on February 25, 2022.
5. Cancellation of Director Election. Pursuant to § 1-13.5-513, C.R.S., if there are not more candidates running than seats to be filled at 5:00 P.M. on February 25, 2022, the DEO shall cancel the portion of the Election related to the director positions and by Resolution declare the candidates elected. Notice of such cancellation shall be published and posted in accordance with law.
6. Severability. If any part or provision of this Resolution is unenforceable or invalid, it shall remain enforceable in accordance with the District Board’s manifest intent.
7. Effective Date. The provisions of this Resolution shall take effect November 18, 2021.
